ELIGIBILITY

All entrants must have a 2015-2016 membership card or receipt. Non-members may qualify by purchasing memberships for \$20.00 or by paying a participation fee of \$5.00. All entrants MUST have bowled an actual 600 series in an USBC-sanctioned league or tournament.

AVERAGES

Highest Standard or Adjusted Sport league Average shall be used in this tournament. All entrants will use their highest 2014-2015 averages, based on a minimum of 21 games. Bowlers not having an established 2014-2015 winter average must use their highest 2015 spring/summer average. Please be advised, composite averages will not be used for this tournament.

Bowlers with no previous season average shall use their current average (12 games or more) as of the first date of bowling (October 10°). Please bring verification of average at the time of bowling. All others will bowl scratch (210). Bowlers are responsible for verifying their own average, whether submitted by the bowler or others. If the submitted average is lower and results in more handicap, the bowler's score is disqualified. If submitted average is higher, prize winnings will be based on the submitted average. Average corrections can be made up to the end of the first game of a series.

RULE 319a(2), 319c, 319d, 319e will NOT be in effect.

HANDICAP/SCRATCH

Handicap will be 90% of 210 with no limit.

PARTICIPATION

Each bowler may bowl each event once. To participate in the all events, the bowler must also bowl the singles and doubles events.
