

## **Minnesota State USBC Association HALL OF FAME QUALIFICATIONS**

The purpose of the Hall of Fame shall be to recognize and perpetuate the names of those people who have achieved outstanding performance and/or who have contributed through meritorious service to the game of American Tenpins in the State of Minnesota

Individuals may be inducted in one of the following categories:

**SUPERIOR PERFORMANCE** (Men and Women)

**MERITORIOUS SERVICE** (Men and Women)

**PIONEER** (Men and Women)

### **GENERAL QUALIFICATIONS FOR ALL APPLICANTS**

1. Nominee shall have been a member of the Minnesota BA, MWBA, and/or USBC for at least 15 years.
2. There shall be no stipulation as to age.

### **SUPERIOR PERFORMANCE QUALIFICATIONS**

This award shall be given to a present or past Minnesota BA, MWBA, YABA, and/or USBC member for their outstanding bowling performance in the State of Minnesota.

1. Nominee must have participated in 10 or more State Championships - not necessarily consecutive.
2. Nominee shall have won state recognition for their ability in bowling and must have at least 4 of the following in sanctioned/certified competition:
  - a. A minimum average of 185 (Women) 200 (Men) for a minimum of 5 years.
  - b. A State Champion in Team, Doubles, Singles, All Events, Team All Events.
  - c. A National Champion in Team, Doubles, Singles, All Events, Team All Events.
  - d. A Local Association Champion in Team, Doubles, Singles, All Events, Team All Events.
  - e. Other tournament titles/accomplishments.
  - f. Exceptional bowling accomplishments.

### **MERITORIOUS SERVICE QUALIFICATIONS**

This award shall be given to a present or past Minnesota BA, MWBA, YABA, and/or USBC member for their meritorious service in the State of Minnesota.

1. Nominee shall have made outstanding contributions to the good and welfare of the game of tenpins through administrative or organizational work.
2. Nominee must have at least 5 of the following:
  - a. Served as an Officer or Director of a Minnesota State Association.
  - b. Served as a Chairperson of a committee of a Minnesota State Association.
  - c. Served on a committee of a Minnesota State Association.
  - d. Served in some capacity at a Minnesota State Tournament.
  - e. Served as a State Delegate
  - f. Served with other State related organizations.
  - g. Contributed valued service to the game of bowling.  
(I.E. Organized bowling events for a charity function, organized bus trips to bowling tournaments, special promotion efforts, etc.)
  - h. Served as a National Officer or Director
  - i. Served on a National Committee as a chairperson of committee member.
  - j. Served as a National Delegate.
  - k. Officer or Director of a Local Association

### **PIONEER**

This award shall be given to a present or past Minnesota BA, MWBA or USBC member for either their **Superior Performance** and/or **Meritorious Service**.
